Results Reward Criteria and Examples

Anthem will reimburse members who lose 5% of their starting weight, their cost of WW up to 6 months. Subsequent reimbursement will only occur for successive 5% losses.

Example 1: You lose 5% of your starting weight within 6 months. You are eligible to receive full reimbursement for the portion you paid for your WW offering, less applicable taxes.

Example 2: You lose 5% of your starting weight within 7 or more months. You are eligible to receive 6 months reimbursement for the portion you paid for your WW offering, less applicable taxes.

Example 3: Your starting weight was 210.5 lbs and you received a “Results Reward” when you reached 200 lbs. (a 5% weight loss). You will need to lose a minimum of 5% from the new starting weight of 200 lbs. (weigh a maximum of 190 lbs.) before you will be able to receive an additional “Results Reward.”

Please remember: If you lost 5% of your starting weight and receive reimbursement BUT you gain that weight back, you cannot receive another “Results Reward” for the 5% again.

Also, when you meet certain criteria, you become a Lifetime Member and may be eligible to participate in the Wellness Workshops at no cost. Ask your WW Coach for more details.

Anthem spouses/domestic partners are eligible receive Anthem preferred rate of \$16.96 per month for the WW Digital program.
