



Frequently asked questions



Q: What is WW?

A: WW is Weight Watchers reimagined. Our purpose is to inspire healthy habits for real life. For people, families, communities, the world, for everyone. No matter what your goal is—to lose weight, eat healthier, move more, develop a more positive mindset, or all the above—we will bring you science-based solutions that fit into your life. WW welcomes everyone who seeks to be healthier, not just manage their weight.

Q: Why is State Fund partnering with WW?

A: State Fund has teamed up with WW to bring you a program that gives you real-life solutions to get healthier.

Q: Who can take advantage of the WW offering?

A: All employees, including seasonal, permanent intermittent employees are eligible for the subsidy. Consultants are NOT eligible to receive the subsidy.

To become a WW member, you must:

- Be at least 18 years old.
- Not be pregnant.
- Not have an active medical diagnosis of bulimia nervosa or anorexia nervosa.

Q: If I register for WW, will my membership and weight information be kept confidential?

A: Yes, it will. Although State Fund will receive information about the total members' weight loss, it will not receive any individual or personally identifiable information.

Q: If I'm a current WW member can I receive the special pricing?

A: Of course! There's an option to link your current account

through your company's registration process. If you have any issues, call WW at 1-866-237-6032 for assistance with getting your membership switched.

Q: What are the WW offerings and monthly cost through State Fund?

A: State Fund is offering a 50% subsidy for joining WW digital only or WW digital + workshop plan!

Offering 1: Digital - \$8.48 per month

Offering 2: Digital + Workshop - \$19.11 per month

Q: What is the Unique ID I use to sign up?

A: Your WW Unique ID is your **State Fund** email address. You will need this to sign up for the special pricing.

Q: Are there any tax implications?

A: Please be advised that the amount State Fund pays on the employee's behalf may have tax consequences and you are solely responsible for any such tax liabilities.

Q: Can I sign up from my State Fund computer?

A: No. In order to access the WW subsidy, you will need to use your personal computer or phone.

Q: How do I cancel my WW membership?

A: Our cancellation process is hassle-free. You can easily cancel your membership on WW website. Simply log in to your account, go to "Settings," > "Account" to view your cancellation options. If you would like assistance with cancelling your account, you can call 866-204- 2885.
