

Spring Forward Stronger Sweepstakes
NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES PERIOD:** The Spring Forward Stronger Sweepstakes (the “Sweepstakes”) begins 12:00 a.m. Eastern Time (“ET”) on May 8, 2021 and ends 11:59 p.m. ET on May 24, 2021 (the “Sweepstakes Period”).
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of 50 United States and District of Columbia, who are 18 years of age or older as of date of entry. Employees of WW North America Holdings, LLC. (“Sponsor”), Don Jagoda Associates, Inc. (“Administrator”), Oprah Winfrey, Harpo, Inc. and Hyatt Corporation and each of their respective parents, affiliates, subsidiaries, advertising, promotion and internet agencies and their immediate family members and/or those living in the same household of each are not eligible to participate or win a prize. Void where prohibited by law.
- 3. HOW TO ENTER:** There is **NO PURCHASE NECESSARY** to participate in the Sweepstakes. A purchase does not increase your chances of winning.

There are three (3) ways to enter:

- **NEW WW MEMBERS:** Any new WW member who signs up on WW.com or in person at a WW studio for the WW Digital, Unlimited Workshops + Digital or Digital 360 membership plan during the Sweepstakes Period will receive one (1) automatic entry into the Sweepstakes. New WW members will have the opportunity to receive bonus entries into the Sweepstakes random drawing by tracking at least one meal daily for three (3) consecutive days during the Sweepstakes Period via their WW account. For every three (3) consecutive days of tracking, they will receive one (1) bonus entry.
- **CURRENT WW MEMBERS:** Current WW members will receive one (1) automatic entry into the Sweepstakes random drawing by tracking at least one meal daily for three (3) consecutive days during the Sweepstakes Period via their WW account. For every three (3) consecutive days of tracking, they will receive one (1) entry.
- **ALTERNATE METHOD OF ENTRY:** You may earn an entry by hand printing your first and last name, street address (no P.O. Boxes), city, state, zip code, date of birth and e-mail address on a plain piece of 3”x 5” paper. Mail your entry in an envelope no larger than #10 (business-size envelope) with sufficient postage affixed to mail to: Spring Forward Stronger Sweepstakes, P.O. Box 7752, Melville, NY 11775-7752. Mail in entries must be postmarked by May 24, 2021 and received by June 1, 2021 to be eligible. Limit one (1) entry per envelope. Entries must contain all information to be eligible, otherwise the entry is void. Entries earned through each of the above methods will be referred to as “Entries”. There is no limit to how many Entries each entrant may earn but you may only receive one (1) entry via sign-up as a new WW member.

- 4. GRAND PRIZE, AND APPROXIMATE RETAIL VALUE (“ARV”): Grand Prize (50):** A 4-day/3-night trip for winner and a guest to winner’s choice of one of three Miraval resorts. Hotel stay will be awarded in the form of a Miraval hotel voucher good for a three (3) night stay in one of three resorts, with all meals and non-alcoholic beverages included, a spa treatment per guest, choice of one (1) culinary experience per guest, unlimited daily participation on signature wellbeing offerings, and complimentary transportation to and from closest major airport/hotel. Also included in the prize is round trip economy air transportation for winner and guest from major airport closest to winner to destination city and \$690, awarded as a check to help offset income tax implications and additional travel expenses. The ARV of each prize is \$4,140. The winner is responsible for all applicable taxes and all other costs and expenses

- 6. RANDOM DRAWING:** Fifty (50) Grand Prize winners will be selected on or about June 2, 2021 from among all eligible Entries received/postmarked during the Sweepstakes Period. The odds of winning a prize will depend on the total number of eligible Entries received/postmarked during the Sweepstakes. The drawing will be conducted by Administrator, an independent judging organization whose decisions are final on all matters relating to the Sweepstakes.
- 7. WINNER NOTIFICATION:** The potential Grand Prize winners will be required to sign and return a Declaration of Eligibility and Liability Release and except where prohibited, publicity release ("**Declaration**") within three (3) days of notification in order to be confirmed as a winner. If a potential winner fails to return the completed Declaration within three (3) days, Declaration is returned as undeliverable, entrant shall be deemed to be ineligible, the prize will be forfeited and an alternate potential winner will be selected. Declarations will be sent via email. Return of any prize notification as undeliverable may result in disqualification and alternate selection. Administrator will make three (3) rounds of attempts to alternates to award prizes (if necessary). After three (3) rounds of attempts to alternates, remaining prizes will go unawarded.
- 8. GENERAL RULES:** By participating in the Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and/or Administrator. Decisions of Administrator/Sponsor are final on all matters relating to the Sweepstakes. addresses for the domain associated with the submitted email address.
